

# PROCEEDINGS: Klemme

**Klemme City Council  
Proceedings  
Monday February 7, 2022**

The Klemme City Council met at the regular meeting on Monday February 7, at 6:30 PM, Council Chambers, City Hall.

The meeting was called to order by Mayor Blank. Present: Abele, Menke, Taft and Boge-Miller. Absent Jergenson.

Boge-Miller made a motion to accept the agenda. Menke seconded the motion. Motion carried.

Taft made a motion to approve the minutes of the previous meeting. Boge-Miller seconded the motion. Motion carried.

Taft made a motion, with a second from Abele, to approve the payment of the bills as presented. Motion carried.

The Sheriff's Report was reviewed.

Mayor Blank opened the public hearing for comments on the proposed property tax levy. There were no comments from the audience. Mayor Blank then closed the public hearing.

Abele made a motion to approve Resolution #02-07-22, Acceptance of the Proposed Property Tax Dollars. Menke seconded the motion. Roll call was made with those voting Aye: Abele, Menke, Taft and Boge-Miller. Those voting Nay: None. Motion carried.

Taft made a motion to approve Tim Molencamp to the Klemme Fire Department. Boge-Miller seconded the motion. Motion carried.

Menke made a motion to accept City Clerk Rout's vacation request. Boge-Miller seconded the motion. Motion carried.

Kenneth Weiland, Public Works Director, was present at the meeting.

Weiland informed the council that he and the City's landfill representative, Abele had been over to purchase and picked up the replacement blade for the City's end loader. With the cold weather a few of the aerators at the lagoon had been freezing up and had to be pulled and replaced, which is to be expected in the cold weather. With the warm weather in the coming week Weiland would be scrapping the streets and putting down salt & sand at the corners as needed.

City Clerk, Colleen Rout, reviewed with the Council the changes that had been made to the 2022/2023 Budget, due to additional information being received.

Menke made a motion to set March 7, 2022 at 6:30 pm in the Council Chambers at City Hall to be the date, time, and place for the public budget hearing. Boge-Miller seconded the motion. Motion carried.

Boge-Miller made a motion, with a second from Taft, to adjourn. Meeting adjourned. Colleen Rout, City Clerk/Treasurer
