- Council has tabled the purchase of fuel tanks until we have a better idea of the outcome with fuel pumps.

- Clean-up at 212 Nicollet is moving along

- Council told PWA to purchase a leaf blower.

- Hankins motioned to set May 11, 2021 as the public hearing of the FY2021 Budget Amendment, Tindall second. Vote: AIF. Absent: Hobscheidt, Fish.

Hankins motioned to adjourn the meeting, Lloyd second. Vote: AIF. Absent: Hobscheidt, Fish. Meeting was adjourned at 7:30 p.m.
