The County Auditor will distribute tax exemption certificates and authorization letters to the Contractor and all subcon-tractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

Payment for work done will be in accordance with estimates approved monthly by the Engineer and in Drainage Warrants issued by the Drainage District, which, if registered and stamped "not paid for want of funds " , shall bear interest at a rate fixed by the Board not to exceed the maximum set by law in accordance with Chapter 468 of the Code of Iowa, as amended. The Board reserves the right to issue Drainage District Improvement Cer-tificates pursuant to Chapter 468 of the Code of Iowa, as amended, which certificates may be given in exchange for outstanding warrants issued to the Contractor or to the holder thereof. Said warrants to be surrendered, if called by the Board, in exchange for Drainage District Improvement Certificates which shall be taken by the Contractor or holder at par and shall bear interest at a rate fixed by the Board not to exceed the maximum set by law in accordance with Chapter 468 of the Code of lowa, as amended.

Progress payments will be made in an amount equal to ninety per-cent (90%) of the work completed. Final payment will be made not less than thirty (30) days after comple-tion of the work and acceptance by the Board, subject to the conditions and in accordance with the provi-sions of Chapter 468 of the Code of lowa, as amended.

PROJECT DESCRIPTION: This project consists of two separate construction alternates with two divisions per alternate.

Alternate 1 Division 1 consists of construction of approximately 828 stations of open ditch excavation, spoil bank leveling, seeding and fertilizing open ditch, riprap stabilization placement, and all other miscellaneous items related thereto.

Alternate 1 Division 2 consists of construction of repairs to surface drain pipes, repairs to tile extension pipes, and all other miscellaneous items related thereto through the 828 stations in Alternate 1 Division Alternate 2 Division 1 consists of

construction of approximately 397 stations of open ditch excavation, spoil bank leveling, seeding and fertilizing open ditch, riprap stabilization placement, and all other miscellaneous items related thereto.

Alternate 2 Division 2 consists of construction of repairs to surface drain pipes, repairs to tile extension pipes, and all other miscellaneous items related thereto through the 397 stations in Alternate 2 Division

Bidders must bid on all Alternates and Divisions. The Board of Supervisors will select any combination of Alternate and/or Division, whichever would be in the best interest of the drainage district.
