The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of May 2, 2022 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Set June 10, 2022, at 3:00 p.m. as the date and time for opening of bids in the Hancock County Board of Supervisors' Meeting Room for Northwest Tower Roof Replacement project with bids being delivered to the Hancock County Engineer's office and set the date and time for consideration of bids for award of said projects for June 13, 2022 at 10:00 a.m. Proclamation declaring May 2022 as Mental Health Month. Six-month class C liquor license with outdoor service and Sunday sales for Hancock County Agricultural Society effective May 9, 2022. Five-day class B beer permit for Hancock County Agricultural Society (Show Ring Area), Britt, Iowa, with outdoor service beginning July 26, 2022. Five-day class B beer permit for Hancock County Agricultural Society (3-Seasons Building), Britt, Iowa, with outdoor service beginning July 26, 2022.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried unanimously,

Five-day class B beer permit for Hancock County Agricultural Society (Old Skating Rink Area), Britt, Iowa, with outdoor service beginning July 26, 2022.
