HANCOCK COUNTY BOARD OF SUPERVISORS October 11, 2021 Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of October 4, 2021 meeting were read and approved.

On motion by Supervisor Grei-man, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: The best and highest bid received for rent for county owned property (Secondary Road ground) as follows: 37.7 acres, section 27, Orthel Township (Hutchins Pit) at \$231 per acre to Tucker Barickman, Garner. Quarterly report of the Hancock County Recorder for the period ending September 30, 2021. Approved revised IT agreement with Next Generation Technologies for an additional \$200 per month for the Sheriff, Dispatch, Attorney for after hours of 10:00 p.m. to 6:00 a.m. CST.

On motion by Supervisor Tlach, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Designation of Blake Norman, County Attorney to sign settlement documents on behalf of Hancock County. Signed agreement with Modus for HVAC study of the Hancock County Courthouse with the base compensation (without the energy model) in the amount of \$6,500.

On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following resolution:

RESOLUTION No. 2021-050 Removal of Bridge Postings

WHEREAS: The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.473 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

WHEREAS: The Hancock County Engineer has caused to be completed the Structure Inventory and Appraisal of certain Hancock County bridges in accordance with the National Bridge Inspection Standards and it has been determined that an adjustment to the bridge's load restrictions have been updated and is no longer required to be posted.

NOW, THEREFORE, BE IT RE-SOLVED by the Hancock County Board of Supervisors that:

FHWA No. 173700 (Local Bridge #2804) on 170th Street over Boone River in Section 31, T-95N, R-26W, Boone Township and is posted as legal.

FHWA No. 173330 (Local Bridge #3266) on 180th Street over E. Branch Iowa River in Section 26, T-95N, R-24W, Liberty Township and is posted as legal.

FHWA No. 173160 (Local Bridge #3694) on 190th Street over Galls Creek/ Drainage Ditch No. 177 Lat. 2 in Section 24, T-95N, R-23W, Ell Township and is posted as legal.

BE IT RESOLVED by the Hancock County Board of Supervisors that:

Resolution Removal of Bridge Posting be amended to reflect above changes in Bridge Weight Limit Posting signed on May 3, 2021.

RESOLUTION #2021-051 RESOLUTION ON USE OF LAW ENFORCEMENT CENTER BASE-MENT MEETING ROOM

WHEREAS the Board of Supervisors of Hancock County, Iowa, has determined to provide guidelines for the use of the Law Enforcement Center basement for government employees and the public; and

WHEREAS, due to limited staff for managing, cleaning and supervision of use and the needs of County government employees for use in training and County projects require restricting access; and

WHEREAS the Board of Supervisors finds that the Law Enforcement Center basement meeting room shall be restricted to use by County employees or events directly sponsored and supervised by a County department head or elected official.

IT IS HEREBY RESOLVED by the Hancock County Board of Supervisors that Hancock County Law Enforcement Center basement meeting room use is restricted to use by County employees or events directly sponsored and supervised by a County department head or elected official related to that department's public purpose.
