

# PROCEEDINGS: Hancock Co.

## HANCOCK COUNTY BOARD OF SUPERVISORS

March 29, 2021

Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of March 22, 2021 meeting were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Revised the Hancock County, Iowa Infectious Disease Action Plan COVID-19 Pandemic January 4, 2021 effective January 1st, 2021 amended February 22, 2021 amended March 29, 2021 to extend the policy to June 30, 2021 and remove the portion in the beginning of the policy stating no vaccine exists. Signed Proclamation for Child Abuse Prevention Month, April and April 1, 2021 as National Child Abuse Awareness day. Approved increase in health insurance rates of 6.6% for Fiscal Year 2021-2022. Class C liquor license with outdoor service and Sunday sales for Slippery Elm Inc. doing business as Slippery Elm Golf Course.

On motion by Supervisor Tlach, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Five letters of nuisance complaints and two rights-of-way letters sent to landowners in Duncan. Hiring of Kyle Eden, Secondary Road Department, effective April 6, 2021 at \$21.82 per hour. Hiring of summer help for Conservation: Harold Curley, Conservation Park Maintenance Mower effective April 26, 2021 at \$10.50 per hour; Michael Hansmeier, Conservation Park Maintenance Mower effective April 26, 2021 at \$10.50 per hour and Benjamin

Blumer, Conservation Aide effective May 20, 2021 at \$11.25 per hour. Signed Wellmark documents: Wellmark rate sheet and Medicare Secondary Payer (MSP) Addendum sheet. No change, from Fiscal Year 2020-2021, to the percentage of the portion of health insurance for employee's contribution to health insurance for Fiscal Year 2021-2022. Approved the best and lowest of two quotes received for replacement of carpet in the Courthouse to In Step Flooring, Kanawha in the amount of \$41,002.95.

On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following resolution:

### **RESOLUTION NO. 2021-022 TEMPORARY ROAD CLOSING**

As per Section 306.41 Code of Iowa be it resolved that the Board of Supervisors of Hancock County hereby declare closed temporarily the following roads in Hancock County due to construction, reconstruction, maintenance or natural disaster. This resolution shall become effective upon placement of temporary road closure signs and shall expire when the said temporary signs are removed upon completion of said project.
