

# PROCEEDINGS: Hancock Co.

## HANCOCK COUNTY BOARD OF SUPERVISORS

June 8, 2020  
Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of June 1, 2020 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Hiring of Connor Bailey, Conservation Park Ranger, effective June 15, 2020 at \$45,000 per year. Accepted the completion of work report for Drainage District no. 1 and 2 South Main Tree Removal Project and set the date and time for completion of work hearing for July 6, 2020 at 10:00 a.m. Accepted the completion of work report for Drainage District no. 169 Open Ditch Repair and Lateral D Tile Improvement and set the date and time for completion of work hearing for July 6, 2020 at 10:30 a.m. Accepted the completion of work report for Drainage District no. 100 Main Tile Improvement and set the date and time for completion of work hearing for July 6, 2020 at 10:50 a.m.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Hiring of Kevin Knebel, Jail Administrator, effective July 6, 2020 at 8:00 a.m. at \$44,000 per year. Hiring of Kayla Moon, Communications Dispatcher/Jailer effective July 11, 2020 at 8:00 a.m. at \$21.23 per hour. Salary certifications for Fiscal Year 2020-2021 to become effective July 1, 2020.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following resolution:

### RESOLUTION NO. 2020-034 TEMPORARY ROAD CLOSING

As per Section 306.41 Code of Iowa be it resolved that the Board of Supervisors of Hancock County hereby declare closed temporarily the following roads in Hancock County due to construction, reconstruction, maintenance or natural disaster. This resolution shall become ef-

fective upon placement of temporary road closure signs and shall expire when the said temporary signs are removed upon completion of said project.

At a joint teleconference with Cerro Gordo County Board of Supervisors, Chris Watts, Tim Latham, and Casey Callanan, Absent: none; and Hancock County Board of Supervisors, Florence (Sis) Greiman, Gary Rayhons, and Jerry Tlach, Absent: none; motion by Supervisor Callanan, seconded by Supervisor Tlach, and carried unanimously, the Joint Board gave approval to the following: Signed the contract for Joint Drainage District no. 13-128 Main Open Ditch and Lateral 7 Repairs with A1 Excavating & Drainage, Inc. in the amount of \$448,399. Motion by Supervisor Latham to adjourn the Joint Board and carried.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board recessed for lunch at 12:55 p.m. and resumed again at 2:30 p.m.

Tlach; County Auditor, Michelle K. Eisenman; County Sheriff, Robert A. Gerdes, Jr.

No further business to come before the Board, motion made to adjourn at 2:58 p.m. by Supervisor Rayhons and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on June 15, 2020.
