

PROCEEDINGS: Klemme

Klemme City Council Proceedings Monday March 1, 2021

The Klemme City Council met at the Klemme City Council on Monday March 1, at 6:30 PM, Community Room, City Hall.

The meeting was called to order by Mayor Blank. Present: Wolf, Boge-Miller, Menke and Taft. Absent Cotty.

Boge-Miller made a motion to accept the agenda. Menke seconded the motion. Motion carried.

Taft made a motion to approve the minutes of the previous meeting. Boge-Miller seconded the motion. Motion carried.

Memke made a motion, with a second from Taft, to approve the payment of the bills as presented. Motion carried.

The Sheriff's Report was reviewed.

The Mayor opened the public hearing for 2021/2022 Budget. There were no public opinions on the city's FY 2021/2022 proposed budget. The Mayor then closed the public hearing.

Wolf made a motion to approve Resolution #03-01-21, acceptance of the fiscal year 2021-2022 budget and instructed the City Clerk to file the necessary paperwork as required by law. Boge-Miller seconded the motion. Roll call was made with those voting Aye: Menke, Taft, Boge-Miller and Wolf. Those voting Nay: None. Motion carried.

Matt O'Brien with NIACOG was present for the initial discussion on the comp planning process. O'Brien discussed with the Council a community survey draft that he had put together. Council discussion was on the best way to distribute the survey to residents for feedback, to incorporate into the City of Klemme's Comprehensive Development Plan.

Taft made a motion to accept the proposed agreement from Iowa Codification, to update the City's Code of Ordinances. Boge-Miller seconded the motion. Motion carried.

Taft made a motion to set the dates for the burning of yard waste from April 1, 2021 to May 31, 2021, unless a burn ban goes into place. Boge-Miller seconded the motion. Motion carried.

Kenneth Weiland, Public Works Director, was present at the meeting.

Weiland informed the council that he had contacted Westrum Leak Detection to help pin point two water leaks, this past month. One located on South 2nd street and the other one on Flogslip and Main. Mort's Water Company fixed both. Westrum proposed leak detection for the whole City at 3 different price rates. Taft made a motion, with a second from Boge-Miller to sign a 5 year contract with Westrum at a cost of \$550.00 per year. Motion carried. Weiland asked council what their thoughts were on having

a clean-up day this year, as due to Covid it was canceled last year. The council informed Weiland to go ahead and contact Waste-Management to find out available dates for May.

Boge-Miller made a motion, with a second from Menke to adjourn. Meeting adjourned. Colleen Rout, City Clerk/Treasurer
